

# Some Observations on Genesis

## Chapter One

- The Bible always assumes and never argues for God's existence. In other places the Bible teaches that God has made Himself known to all men "in the things that have been made" (the creation) and therefore those who deny His existence are fools who wickedly suppress that knowledge and are without excuse.
  - Romans 1:18-20 - *The wrath of God is revealed from heaven against all ungodliness and unrighteousness of men, who by their unrighteousness suppress the truth. For what can be known about God is plain to them, because God has shown it to them. For his invisible attributes, namely, his eternal power and divine nature, have been clearly perceived, ever since the creation of the world, in the things that have been made. So they are without excuse.*
  - Psalm 53:1 - *The fool says in his heart, "There is no God."*

# Some Observations on Genesis

## Chapter One

- God could have made everything in an instant, but instead He took six days.
- God created the entire universe out of nothing
  - Genesis 1:1 - *In the beginning, God created (Hebrew: *bara*) the heavens and the earth.*
  - Hebrews 11:3 - *By faith we understand that the universe was created by the word of God, so that what is seen was not made out of things that are visible.*

# Some Observations on Genesis

## Chapter One

- As God creates, He speaks things into existence
  - Gen 1:3 - *And God said, "Let there be light," and there was light.*
  - Gen 1:9 - *And God said, "Let the waters under the heavens be gathered together into one place, and let the dry land appear." And it was so.*
  - Gen 1:11 - *And God said, "Let the earth sprout vegetation, plants yielding seed, and fruit trees bearing fruit in which is their seed, each according to its kind, on the earth." And it was so.*
  - Psalm 33:6-9 - *By the word of the LORD were the heavens made . . . He spoke, and it came to be; He commanded, and it stood firm.*


# Some Observations on Genesis

## Chapter One


- God created light before He created the sun, moon or stars (vs.3 cf. vs. 14-18)
- God directly created each of the various kinds of living things and caused them to reproduce after their “own kind” (vs. 11-12, 21, 24-25)
- Man was created in God's image (vs.26-27)
- In the original creation man and animals ate only vegetables (vs.29-30)
- Over and over, God declared His creation to be "good" (vs. 4,10,12,18,21,25,31)







# Creation and Evolution

## Two Irreconcilable Religious Views

### Evolution

The universe is either eternal or it brought itself into existence.

Present reality consists only of that which is observable

The order and beauty that we observe in the universe around us is the result of impersonal random forces acting without purpose over long periods of time.

Life came from non-life by impersonal random processes acting over long periods of time.

### Creation

Only God is self-existent and eternal.

There is a whole realm of reality that cannot be seen.

The order and beauty that we observe in the universe around us is the creation of an all-knowing, all-powerful God who purposefully designed and created it for our benefit and ultimately for His own glory.

God created life.

# Creation and Evolution

## Two Irreconcilable Religious Views

### Evolution

All life as we know it descended from a common primitive ancestor

Man is just another kind of animal and has no more significance than an ant or an elephant.

The universe is evolving into a better place.

The earth and the universe is billions of years old, life is millions of years old.

### Creation


God directly created each kind of living thing and caused each living thing to reproduce “after its own kind”.

# What about Theistic Evolution?

Why couldn't God have used evolutionary processes to create the universe?

- The story of evolution was made up as a way of explaining how the Universe got here without God.
- If God did in fact use evolutionary processes (as described by the theory of evolution) to create the universe, what that means is that God knowingly told us many untrue things in the biblical creation account!
- Contrary to what many would have you believe, there are huge scientific problems with the theory of evolution.



## 17.6 The Origin of the Universe

If the universe is expanding, then it must have once been much smaller. If you could run the life of the universe in reverse, like a film, you would see the universe contracting until it disappeared in a flash of light, leaving nothing.

In the realm of the universe, *nothing* really means *nothing*. Not only matter and energy would disappear, but also space and time. However, physicists theorize that from this state of nothingness the universe began in a gigantic explosion about 16.5 billion years ago. This theory of the origin of the universe is called the **Big Bang theory**. The Big Bang theory does not know the universe began. The theory only explains how the existing universe could have developed.




# Something from Nothing?

- The idea that *something* came from *nothing* is a philosophical absurdity!
- It is also a violation of the **First Law of Thermodynamics**, which tells us that: “*Energy can neither be created nor destroyed*”

# Has The Universe Always Been Here?

- The universe as we know it **cannot** be infinitely old.
- The reason? Because according to the Second Law of Thermodynamics, the universe is running down or “wearing out”.
- **Second Law of Thermodynamics** (more formally stated): *“in all energy exchanges, if no energy enters or leaves the system, the potential energy of the state will always be less than that of the initial state.”*


# Scientific Objections to Organic Evolution



# Scientific Objections to “Goo-to-You” Evolution

## Gaps in the Fossil Record

- Evolutionists **claim** that the layers of rocks containing the fossils of dead plants and animals found throughout the world were laid down over millions of years and therefore **provide us with a record** of what the plants and animals that lived in the past looked like.
- Evolutionists also **claim** that **living things gradually evolved** over those millions of years from a single cell to the complex forms of life we see today.

# Scientific Objections to “Goo-to-You” Evolution

## Gaps in the Fossil Record

- So if evolution is true, we should expect to see evidence in the fossil record of living things gradually transitioning from one kind of living thing to another.
- But we don't see this! Instead there are gaps throughout the fossil record with new kinds of organisms appearing suddenly and with very few, if any, intermediate links.

# Scientific Objections to “Goo-to-You” Evolution

## Gaps in the Fossil Record

- *Darwin said that the absence of such intermediates was the ‘most obvious and serious objection’ against his theory. One hundred and twenty years later, Dr. David Raup, head of one of the great museums in America, said that the situation concerning missing links ‘hasn’t changed much’ and that ‘we have even fewer examples of evolutionary transition than we had in Darwin’s time’.* \*

# Scientific Objections to “Goo-to-You” Evolution

## Gaps in the Fossil Record

- Some evolutionists claim there are some – maybe a handful of such in-between fossil types. Other leading experts say there are none. (Stones and Bones, p.14)
- But if evolution is true, there should be millions of in-between forms. Where are they?

# Scientific Objections to “Goo-to-You” Evolution


## Similar Structures Do Not Prove Ancestry

- One of the primary “evidences” that evolutionists offer to “prove” their theory is the **similarity** of living things.
- They **assume** that if two living things have similar characteristics they must be closely related.
- But this is an **unproven assumption!**


# Evidence of Evolution: Comparing Organisms






The similarities indicate that animals as different as a cat, a dolphin, a bat, and a human are all related by a common ancestor. The evolutionary process has modified these bones over millions of years to perform specific functions.

# Scientific Objections to “Goo-to-You” Evolution

## Similar Structures Do Not Prove Ancestry

- Similarities between living things **may** instead show that living things have a **common designer**. After all, one would expect a similar design for a similar structure or purpose from the hand of the same Designer.

# Scientific Objections to “Goo-to-You” Evolution

## We Don’t See Evolution Happening\*

- Living things do change. But we know that **every living thing contains a set of instructions**, like a blueprint or a recipe that specifies whether it will be an amoeba or a horse, for example.
- This information is written on a long molecule called **DNA**.

# Scientific Objections to “Goo-to-You” Evolution

## We Don’t See Evolution Happening\*

- Evolution teaches that (over millions of years) a comparatively **simple** creature , like the one celled amoeba, has become a much more **complicated** one, like a horse.
- But amoebas clearly do not contain as much **information** as a horse. They don’t have instructions specifying how to make eyes, blood, brains, hooves, muscles, etc.

Real evolution requires huge increases in DNA information (symbolized here as books)



# Scientific Objections to “Goo-to-You” Evolution

## We Don’t See Evolution Happening\*

- So for an amoeba to evolve into a horse would require an **increase in information**. Information coding for new structures, new functions – new useful complexity.
- If we saw those sorts of information-increasing changes happening, even if only a few, this could reasonably be used to help support the argument that fish may indeed evolve into philosophers!


# Scientific Objections to “Goo-to-You” Evolution

## We Don’t See Evolution Happening\*

- But the changes that we observe in living things today do not involve increasing information.
- Instead, we see that when living things reproduce, they pass on either the same or less information, not more.
- Therefore the changes that we see are heading in the wrong direction for evolution to occur!

# Natural Selection is not the same as Evolution\*

- Just as someone who breeds dogs (or anything else) can only work with the genetic information that is already there, so it is with the process of natural selection.
- In fact, starting with a short breed of dogs no amount of breeding and selection will produce a tall variety of dogs, because some of the “tall” information has been lost in that population.

# Natural Selection is not the same as Evolution\*

- In the same way, “nature” can “select” animals with a physical trait that is beneficial in a given environment, by allowing it to survive longer and pass that trait on to others.
- But natural selection cannot create any new information within a population of animals, it can only select from the traits that are already there.

# Beneficial Mutations?

- When the genetic code within the gene of a living thing is corrupted or damaged, this is known as a mutation.
- If a mutation is passed on to the offspring of a living thing it can result in the offspring having a characteristic that is not found within the genetic code of either of its parent(s).
- Because mutations are the result of random damage, they are almost never beneficial, but harmful – much like the accidental splattering of ink on the page of a book is not very likely to improve what is written there!

# Beneficial Mutations?


- Evolutionists know that mutations are overwhelmingly harmful but their belief system demands that there must have been beneficial mutations on occasion.
- There are, in fact, a tiny handful of mutations known which make it easier for an organism to survive in a given environment:
  - Eyeless fish in caves survive better as they are not prone to eye disease/injury
  - Wingless beetles do better on a windy rock in the sea because they are less likely to be blown away and drowned.

# Beneficial Mutations?

- But the loss of eyes or the loss of information necessary to manufacture wings is a defect - a crippling of a previously functional piece of machinery.
- Such changes, though “beneficial” in a purely survival sense, are not an example of increases in information - new coding for new functions, new useful structures.
- It’s no use turning to insecticide resistance in insects - in almost every case the information for resistance was there in a few individuals in the population before man began to spray.

# Peppered Moths – The Rest of the Story\*

- The textbook story of England's famous peppered moths goes like this:
  - The moths come in light and dark forms.
  - Pollution from the Industrial Revolution darkened the tree trunks.
  - The lighter moths which had been well camouflaged against the light background now stood out and so birds more readily ate them.
  - Therefore the proportion of the dark moths increased dramatically.
  - Later, pollution was cleaned up, and the light moth became predominant again.

# Peppered Moths – The Rest of the Story

- When the story of the peppered moths first came out, evolutionists were very enthusiastic about it.
- H.B. Kettlewell who performed most of the classic experiments, said that if Darwin had seen the peppered moth experiment, “He would have witnessed the consummation and confirmation of his life’s work.”

# Peppered Moths – The Rest of the Story

- Note: Even as it stands, the peppered moth story only shows an increase or decrease of an existing characteristic within the moth population caused by natural selection.
- There were both dark moths and light moths before, during and after the Industrial Revolution that darkened the tree trunks. No new traits appeared; no new information was added to the moth population.
- Therefore the peppered moth story does not show the kind of increase in information that is necessary for amoeba-to-man evolution to occur.

# Peppered Moths – The Rest of the Story

- But as it turns out, this classic story is full of holes anyway:
  - Peppered moths don't even rest on tree trunks during the day - the latest story is that they rest on the leaves in the tops of the trees, but no one really knows for sure!
  - The moths filmed being eaten by the birds were laboratory-bred ones placed onto tree trunks by Kettlewell!
  - And all those still photos of moths on tree trunks? One paper described how it was done – dead moths were glued to the tree. University of Massachusetts biologist Theodore Sargent helped glue moths onto trees for a NOVA documentary. He says textbooks and films have featured “a lot of fraudulent photographs.”

# Peppered Moths – The Rest of the Story

- University of Chicago evolutionary biologist Jerry Coyne agrees that the peppered moth story, which was “the prize horse in our stable”, has to be thrown out
- He says the realization gave him the same feeling as when he found out that Santa Clause wasn’t real!
- Regrettably, hundreds of millions of students have once more been indoctrinated with “proof of evolution” which is riddled with error, fraud and half-truths.
