God's Instructions to Noah

(Genesis 8:15-9:7)

¹⁵ Then God said to Noah, ¹⁶ "Go out from the ark, you and your wife, and your sons and your sons' wives with you. ¹⁷ Bring out with you every living thing that is with you of all flesh-- birds and animals and every creeping thing that creeps on the earth-- that they may swarm on the earth, and be fruitful and multiply on the earth." ¹⁸ So Noah went out, and his sons and his wife and his sons' wives with him. ¹⁹ Every beast, every creeping thing, and every bird, everything that moves on the earth, went out by families from the ark.

Neither will I ever again strike down every living creature as I have done. ²² While the earth remains, seedtime and harvest, cold and heat, summer and winter, day and night, shall not cease."

From his fellow man I will require a reckoning for the life of man. ⁶ "Whoever sheds the blood of man, by man shall his blood be shed, for God made man in his own image. ⁷ And you, be fruitful and multiply, increase greatly on the earth and multiply in it.

God Makes a Covenant With Noah and All Living Creatures (Genesis 9:8-17)

⁸ Then God said to Noah and to his sons with him, ⁹ "Behold, I establish my covenant with you and your offspring after you, ¹⁰ and with every living creature that is with you, the birds, the livestock, and every beast of the earth with you, as many as came out of the ark; it is for every beast of the earth. ¹¹ I establish my covenant with you, that never again shall all flesh be cut off by the waters of the flood, and never again shall there be a flood to destroy the earth." ¹² And God said, "This is the sign of the covenant that I make between me and you and every living creature that is with you, for all future generations: ¹³ I have set my bow in the cloud, and it shall be a sign of the covenant between me and the earth.

Genesis 9:18-29 – The Sons of Noah

*¹⁸ The sons of **Noah** who went forth from the ark were **Shem, Ham, and Japheth**. (Ham was the father of Canaan.) ¹⁹ These three were the sons of Noah, and from these the people of the whole earth were dispersed. ²⁰ Noah began to be a man of the soil, and he planted a vineyard. ²¹ He drank of the wine and became drunk and lay uncovered in his tent. ²² And Ham, the father of Canaan, saw the nakedness of his father and told his two brothers outside. ²³ Then Shem and Japheth took a garment, laid it on both their shoulders, and walked backward and covered the nakedness of their father. Their faces were turned backward, and they did not see their father's nakedness.*

Genesis 9:18-29 – The Sons of Noah (continued)

²⁴ When Noah awoke from his wine and knew what his youngest son had done to him, ²⁵ he said, "Cursed be Canaan; a servant of servants shall he be to his brothers." ²⁶ He also said, "Blessed be the LORD, the God of Shem; and let Canaan be his servant. ²⁷ May God enlarge Japheth, and let him dwell in the tents of Shem, and let Canaan be his servant." ²⁸ After the flood Noah lived 350 years. ²⁹ All the days of Noah were 950 years, and he died.

The Table of Nations*

- Even the liberals have often admitted that the tenth chapter of Genesis is a remarkably accurate historical document. It is unparalleled in its antiquity and comprehensiveness.
- Genesis 10, or the “Table of Nations” as it is often called, is the one link between the historic nations of antiquity and the prehistoric times of Noah and those who lived before the flood.
- The grandsons and great-grandsons of Noah are listed, each of whom is identified with the city or country established by his descendants.

Genesis 10:1-5 – The Sons of Jepheth

*¹ These are the generations of the sons of Noah, Shem, Ham, and **Japheth**. Sons were born to them after the flood. ² **The sons of Japheth**: Gomer, Magog, Madai, Javan, Tubal, Meshech, and Tiras. ³ The sons of Gomer: Ashkenaz, Riphath, and Togarmah. ⁴ The sons of Javan: Elishah, Tarshish, Kittim, and Dodanim. ⁵ From these the coastland peoples spread in their lands, each with his own language, by their clans, in their nations.*

The Sons of Japheth

- There is enough clear identification to recognize that the descendants of Japheth spread all over Europe with one major branch heading eastward into Persia and India.
- **Gomer** is identified by Herodotus, Plutarch and other ancient writers with the district of Cimmeria, north of the Black Sea, a name surviving in the present form of Crimea.
- The Jews identified Gomer's son **Ashkenaz** with Germany and, to this day, German Jews are called Ashkenazi.
- **Magog** along with Meshech and Tubal (Ezek 38:2) are thought to be the ancestors of the modern Russian peoples

The Sons of Japheth

- **Madai** according to all authorities is the ancestor of the Medes. They settled in what is now Persia
- **Javan** is the original form of Ionia, known to us as Greece.
- The Iliad mentions the Eileasian people, the descendants of Javan's son **Elishah**.
- It is possible that the early descendants of **Tarshish** may have been the early settlers of Spain and North Africa.
- **Kittim** is almost certainly a reference to Cyprus and possibly to the Greek mainland.
- The descendants of Japheth were in general of an intellectual and philosophical turn of mind. This fact later made Europe the center of development of philosophy and science.

Genesis 10:6-20 – The Sons of Ham

⁶ The sons of Ham: Cush, Egypt, Put, and Canaan. ⁷ The sons of Cush: Seba, Havilah, Sabtah, Raamah, and Sabteca. The sons of Raamah: Sheba and Dedan. ⁸ Cush fathered Nimrod; he was the first on earth to be a mighty man. ⁹ He was a mighty hunter before the LORD. Therefore it is said, "Like Nimrod a mighty hunter before the LORD." ¹⁰ The beginning of his kingdom was Babel, Erech, Accad, and Calneh, in the land of Shinar. ¹¹ From that land he went into Assyria and built Nineveh, Rehoboth-Ir, Calah, and ¹² Resen between Nineveh and Calah; that is the great city.

Genesis 10:6-20 – The Sons of Ham (Continued)

*⁶ **The sons of Ham:** Cush, Egypt, Put, and Canaan...¹³ Egypt fathered Ludim, Anamim, Lehabim, Naphtuhim, ¹⁴ Pathrusim, Casluhim (from whom the Philistines came), and Caphtorim. ¹⁵ Canaan fathered Sidon his firstborn and Heth, ¹⁶ and the Jebusites, the Amorites, the Girgashites, ¹⁷ the Hivites, the Arkites, the Sinites, ¹⁸ the Arvadites, the Zemarites, and the Hamathites. Afterward the clans of the Canaanites dispersed. ¹⁹ And the territory of the Canaanites extended from Sidon in the direction of Gerar as far as Gaza, and in the direction of Sodom, Gomorrah, Admah, and Zeboiim, as far as Lasha. ²⁰ These are the sons of Ham, by their clans, their languages, their lands, and their nations.*

The Sons of Ham

- Ham's son **Cush** is the same in the Bible as Ethiopia.
- **Mizraim** is the ancestor of the Egyptians. Egypt is also called the "land of Ham" (Psalm 105:23)
- **Put**, in the Bible, is the same as Libya, applied to the region of North Africa west of Egypt. This identification was confirmed by Josephus.
- **Canaan** is, of course, the ancestor of the Canaanites.
- Canaan's son **Heth** is undoubtedly the ancestor of the Hittites (Gen 23:10)

Genesis 10:21-32 – The Sons of Shem

²¹ To **Shem** also, the father of all the children of Eber, the elder brother of Japheth, children were born. ²² **The sons of Shem:** Elam, Asshur, Arpachshad, Lud, and Aram. ²³ The sons of Aram: Uz, Hul, Gether, and Mash. ²⁴ Arpachshad fathered Shelah; and Shelah fathered Eber. ²⁵ To Eber were born two sons: the name of **the one was Peleg, for in his days the earth was divided**, and his brother's name was Joktan. ²⁶ Joktan fathered Almodad, Sheleph, Hazarmaveth, Jerah, ²⁷ Hadoram, Uzal, Diklah, ²⁸ Obal, Abimael, Sheba, ²⁹ Ophir, Havilah, and Jobab; all these were the sons of Joktan. ³⁰ The territory in which they lived extended from Mesha in the direction of Sephar to the hill country of the east. ³¹ These are the sons of Shem, by their clans, their languages, their lands, and their nations. ³² These are the clans of the sons of Noah, according to their genealogies, in their nations, and from these the nations spread abroad on the earth after the flood.

The Sons of Shem

- Shem is identified as “the father of all the children of **Eber**”. It is from “Eber” that the term “Hebrew” has apparently been derived. The term obviously is applied in these early scriptures to a much larger group of peoples than to only the descendants of Abraham.
- **Elam** is the ancestor of the Elamites, well known in both scripture and ancient monuments. The Elamites apparently later merged with others, especially the Medes to form the Persian empire.
- **Asshur** was evidently the founder of the Assyrians. However as Gen 10:11 records, Nimrod and his followers later invaded the land of Asshur and there founded Ninevah (later to become the capital). Consequently the Assyrian people were a mixture of both Semitic racial stock and Hamitic culture, language, and religion.

The Sons of Shem

- **Lud** was the ancestor of the Lydians in Asia Minor according to Josephus.
- **Aram** is the father of the Arameans, same as the Syrians. These people became a great nation and are the ones who developed the Aramaic language, adopted as a common language for the leading nations of the ancient world including Assyria and Babylonia. Some of the Old Testament (portions of Daniel and Ezra) were originally written in Aramaic, and it was a common spoken language among the Jews at the time of Christ.
- **Uz** evidently gave his name to a region of Arabia which was later Job's homeland (Job 1:1)

The Sons of Shem

- The most important son of Shem was **Arphaxad**, since he was in the line of the promised Seed.
- He is the father of the **Selah** who is the father of **Eber**.
- Eber named his son **Peleg** (meaning “division”) because “in his days the earth was divided” apparently a reference to the dividing of languages at the tower of Babel.
- One remarkable feature of the Table of Nations is that there are exactly seventy families of the sons of Noah mentioned by name. There may well have been others, but for some reason only seventy are listed.

GENEALOGICAL TABLE OF THE DESCENDANTS OF NOAH

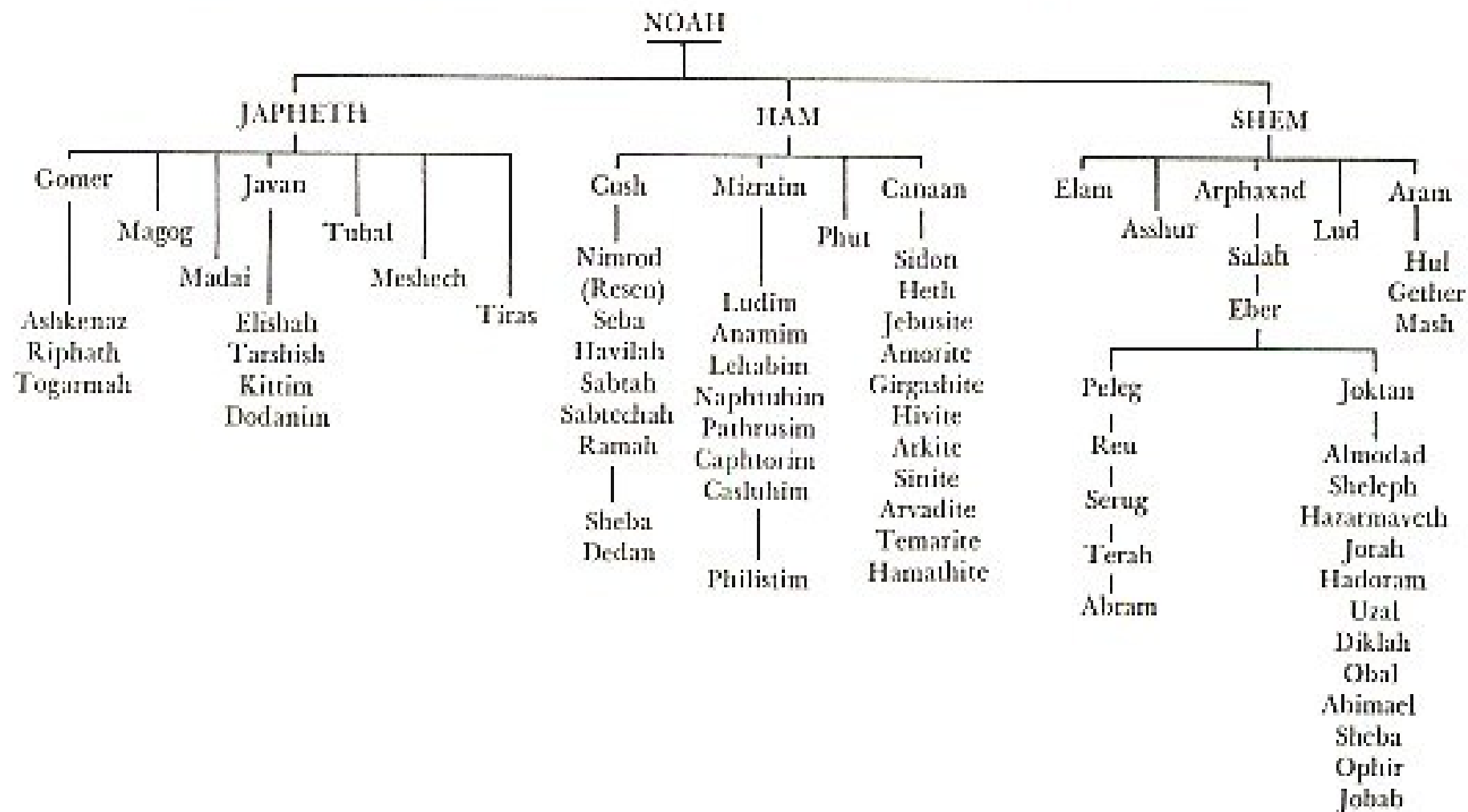


Table of Nations – Genesis 10:1-32

Genesis 11:1-9 – The Tower of Babel

¹ Now the whole earth had one language and the same words. ² And as people migrated from the east, they found a plain in the land of Shinar and settled there. ³ And they said to one another, "Come, let us make bricks, and burn them thoroughly." And they had brick for stone, and bitumen for mortar. ⁴ Then they said, "Come, let us build ourselves a city and a tower with its top in the heavens, and let us make a name for ourselves, lest we be dispersed over the face of the whole earth." ⁵ And the LORD came down to see the city and the tower, which the children of man had built.

Genesis 11:1-9 – The Tower of Babel (Continued)

⁶ And the LORD said, “Behold, they are one people, and they have all one language, and this is only the beginning of what they will do. And nothing that they propose to do will now be impossible for them. ⁷ Come, let us go down and there confuse their language, so that they may not understand one another's speech.” ⁸ So the LORD dispersed them from there over the face of all the earth, and they left off building the city. ⁹ Therefore its name was called Babel, because there the LORD confused the language of all the earth. And from there the LORD dispersed them over the face of all the earth.



Tongue Twisting Tales

Tongue Twisting Tales

- As we have seen, there are many stories about a global Flood and a surviving family are worldwide.
- While not as common, there are also many stories about a time when there was only one language and how God divided them.

Central America

- An Aztec legend claimed:
 - “Humanity was wiped out by a flood, but one man Coxcoxtli and one woman Xochiquetzal escaped in a boat, and reached a mountain called Colhuacan.
 - They had many children, who were dumb until the time when a dove on top of a tree made them the gift of languages; but these differed so much that the children could not understand each other.”

Guatemala

- The Quiches (Mayan Indians) of Guatemala told of a time when the tribes multiplied and left their old home to a place called Tulan.
- Here the language changed, and the people sought new homes in various parts of the world as a result of not being able to understand each other.

Africa

- A legend of the Wa-Sania tribe in East Africa says
 - *“that of old all the tribes of the earth knew only one language, but that during a severe famine the people went mad and wandered in all directions, jabbering strange words, and so the different languages arose.”*

India

- The Mikir tribe in northeastern India tells of the descendants of Ram who were strong men and were growing dissatisfied with earth and aspired to conquer heaven. They began to build a tower.
 - *“Higher and higher rose the building, till at last the gods and demons feared lest these giants should become the masters of heaven, as they already were of earth.*
 - *So they confounded their speech, and scattered them to the four corners of the world. Hence arose all the various tongues of mankind.”*

Europe

- The Greeks had a legend that
 - *“for many ages men lived at peace, without cities and without laws, speaking one language, and ruled by Zeus alone. . . . At last Hermes introduced diversities of speech and divided mankind into separate nations.”*

Polynesia

- Polynesians on the island of Hao said that Rata and his three sons survived a great flood. Then
 - *“they made an attempt to erect a building by which they could reach the sky, and see the creator god Vatea; but the god in anger chased the builders away, broke down the building, and changed their language, so that they spoke diverse tongues.”*

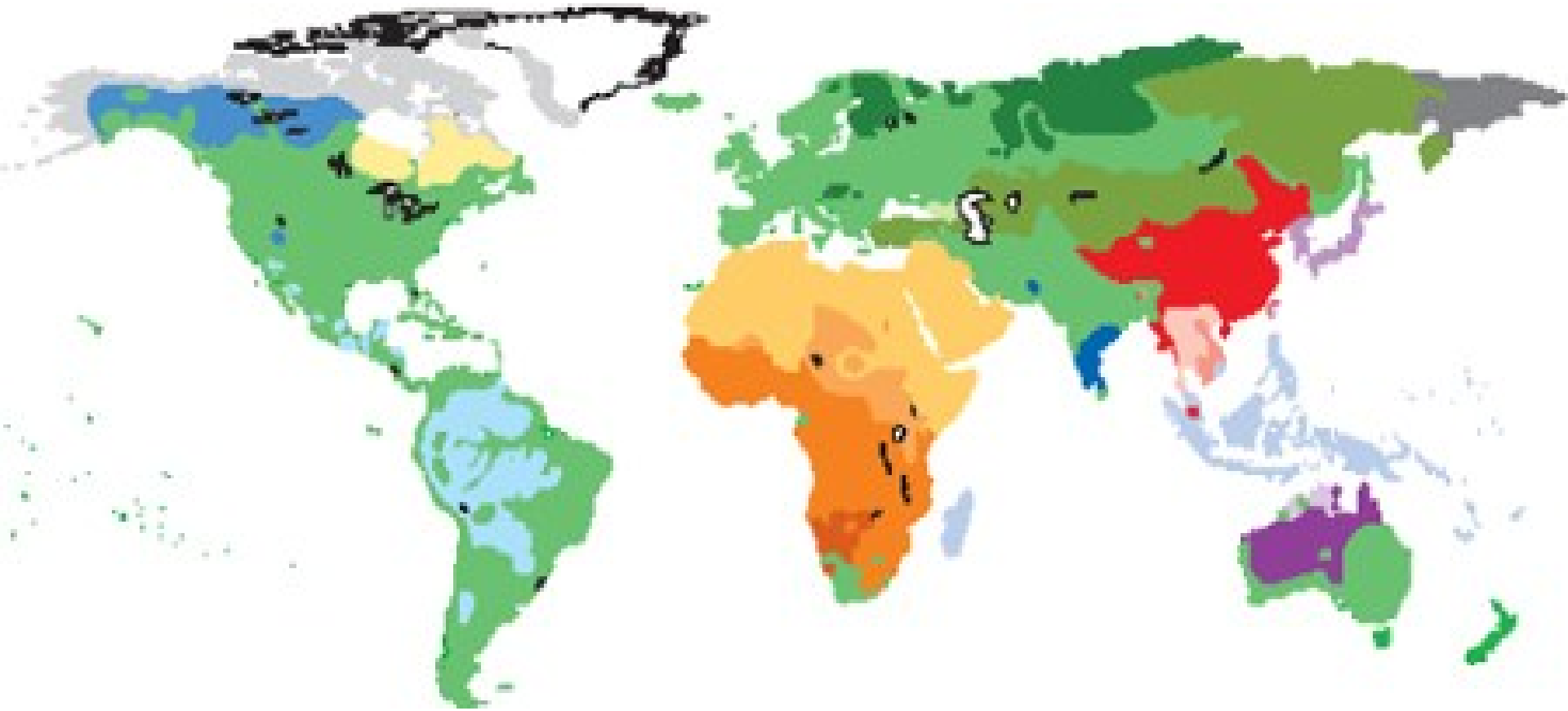
Middle East

- Sumerians believed that all people spoke one language, as claimed in the poem “Enmerkar and the Lord of Aratta”:
 - *In those days ... the people [were] in unison, ...*
 - *Enki, the Lord of abundance, ... changed the speech in their mouths, and [brought] contention into the speech of man that [until then] had been one.*

Southeast Asia

- A legend of the Gaikho tribe of Burma (Myanmar) says,
 - *“In the days of Pan-dan-man, the people determined to build a pagoda that should reach up to heaven. . . .*
 - *When the pagoda was half way up to heaven, God came down and confounded the language of the people, so that they could not understand each other.*
 - *Then the people scattered, and Than-mau-rai, the father of the Gaikho tribe, came west, with eight chiefs, and settled in the valley of the Sitang.”*

Origin of World Languages

- About 6,912 distinct languages exist in the world today.
- The Bible says God confounded the language at Babel to separate the people and stop their advance into the heavens.
- Secular theories argue that *all* language differences are a result of differences in language that naturally occur when people are separated.
- So which story fits the facts? The miracle of Babel or gradual change? How did we get all these languages?

Origin of World Languages

- Languages *do* tend to change over time:
 - The English of Beowulf's time—between AD 680 and 800—is unintelligible to speakers of modern English
 - Modern English is dated roughly from Shakespeare (1564–1616) and the King James Bible (1611). If we met Shakespeare today, we would understand him, but not folks from Beowulf's time.

Origin of World Languages

- By studying existing languages we can often determine their recent origin.
- For example, with the help of written records, we know that French and Spanish (also, Italian, Portuguese, and Romanian) come from Latin.
- Based on similarities as simple as the numbers un—uno, deux—dos, and trois—tres, we can see evidence of a common source language.
- But Chinese numbers do not resemble French, Spanish, or English at all. The first three numbers in Chinese are yī, èr, sān.

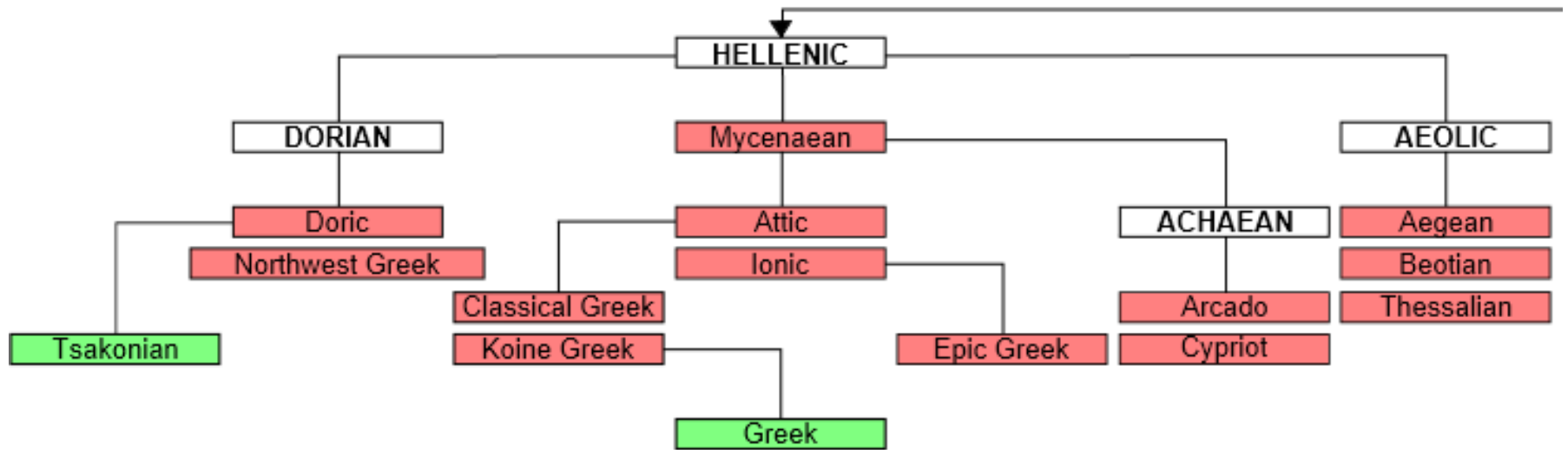
Origin of World Languages

- From evidences like this, linguists can infer family relations between languages, and can partially reconstruct “protolanguages” and theoretical family trees of languages that show where modern languages come from.
- One of the most widely studied language groups in the world is a group made up of about 449 distinct languages known to linguists as the Indo-European language family.

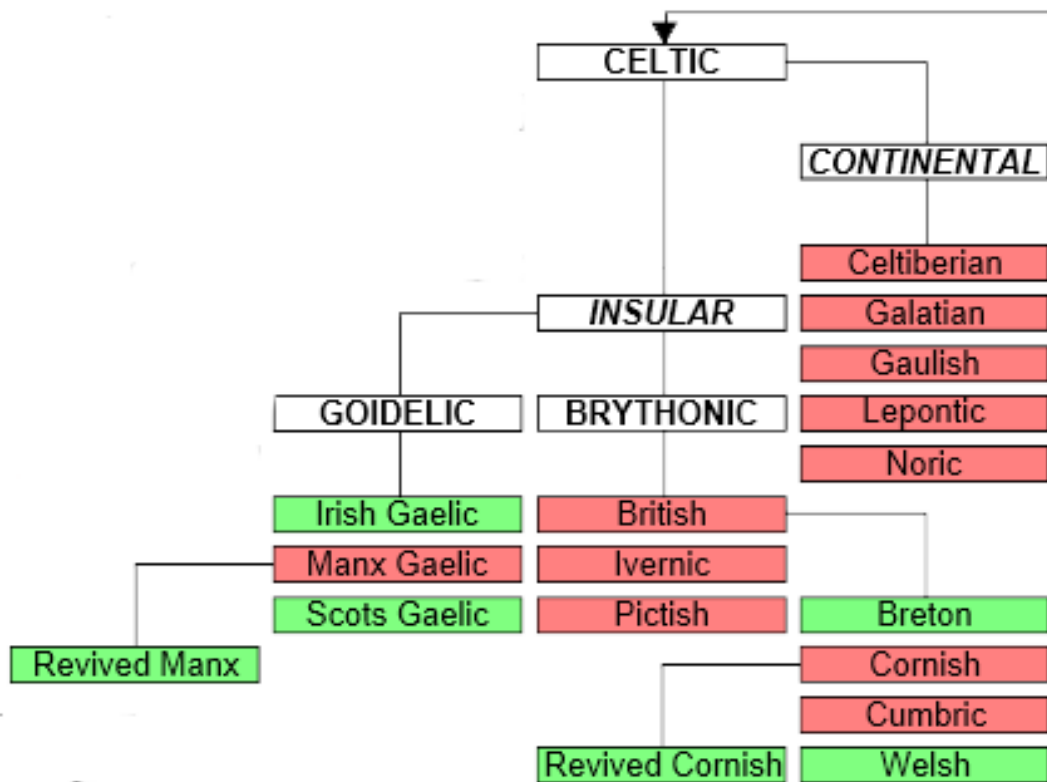
Origin of World Languages

- **Approximately 45 percent of the people in the world today speak one of the languages in this group. It includes Greek, Latin, Spanish, French, German, English, and Russian.**
- **All these languages are thought to have come from a single source commonly known as Proto-Indo-European (PIE).**
- **Based on the scant historical evidence, secular linguists believe PIE was spoken in Europe sometime between the third and seventh millennium BC, give or take a couple thousand years.**

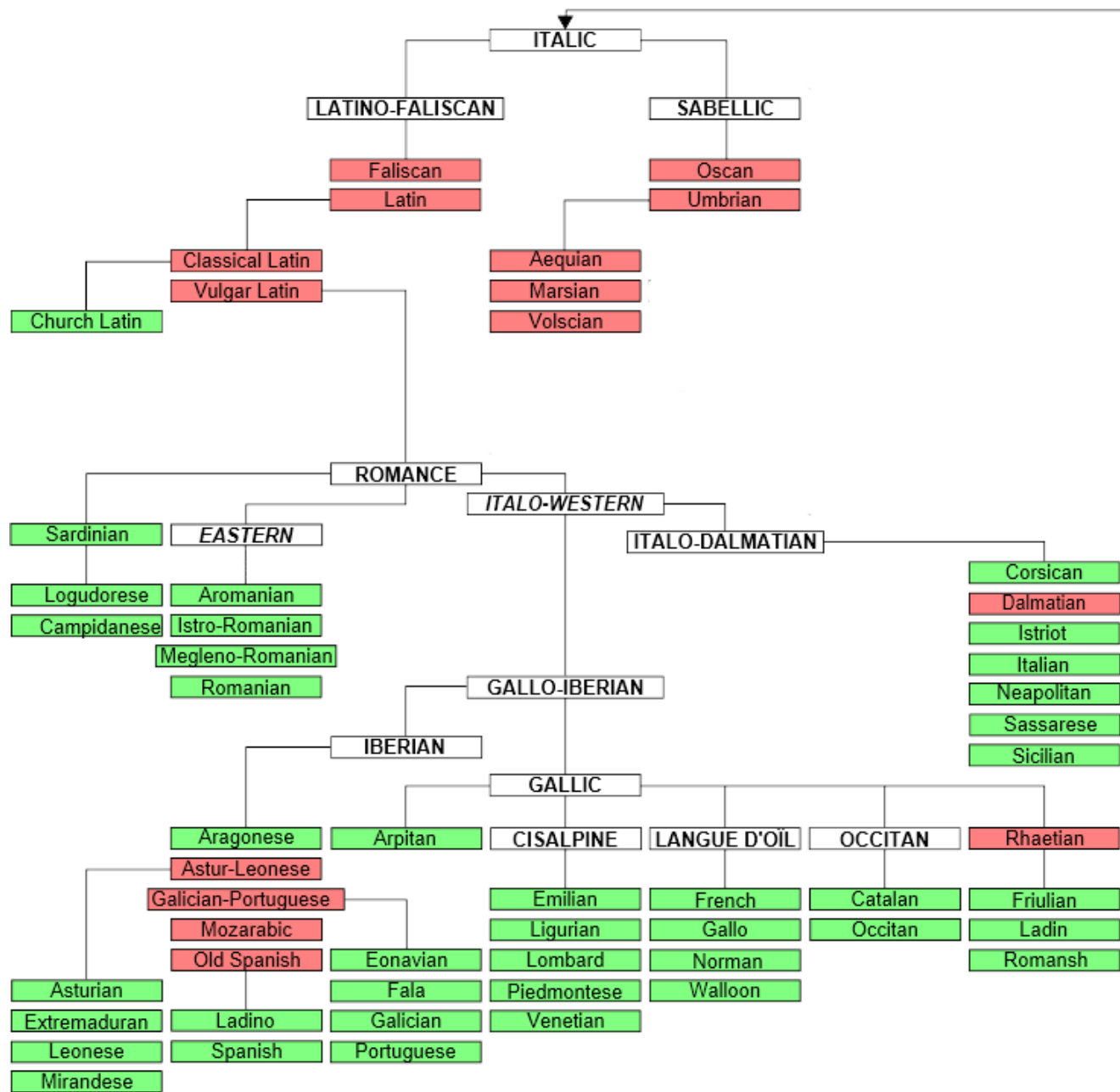

Origin of World Languages

- The next most widely spoken language family is the Sino-Tibetan group, which includes Chinese.
- It is estimated to have about 403 distinct languages and accounts for about 22 percent of the world's population.
- That language family, too, is believed to have come from a common source, but *different* from Proto-Indo-European (PIE).
- Neither of these distinct source languages, however, can reasonably be dated earlier than the miracle at Babel.

Origin of World Languages

- Besides these two families, 92 other distinct language families are thought to exist.
- There are two secular theories given to explain the world's diverse languages:
 - All these language groups (and their derived languages) came from a single original language,
 - Or the language capacity must have evolved and expressed itself multiple times.
- Both ideas have been advocated by secular linguists, but neither idea makes much sense.

Origin of World Languages

- The idea that something as complex as human language could arise by chance even *once* defies all common sense.
- The idea that the language capacity could come about by chance *more* than once is simply unbelievable.
- Furthermore, no one has shown how language families as different as Proto-Indo-European and Proto-Sino-Tibetan could derive from a common source.
- The vast differences in the various language groups cannot be convincingly explained by mere change of languages over time.

Origin of World Languages

- On the other hand, the account given in scripture of the tower of Babel fits very nicely with the evidence that we see in the languages of the world today.
- Because God's purpose at Babel was to confuse men's ability to understand one another, we would *expect* that the languages created at Babel to be radically distinct from each other.

Origin of World Languages

- Furthermore, when we study the rate of change in language that has occurred in *known* language subgroups—notably those based on Latin, Sanskrit, Greek, and the Germanic and Slavic languages—we can see that all the languages in the world today could easily have been produced within the space of about 4,000 years that have passed since the tower of Babel.

How Did the Different Races of Men Arise From Noah and His Family?

- According to the Bible, all humans on earth today are descended from Noah and his wife, his three sons and their wives and before that from Adam and Eve.
 - Acts 17:26 - *And he made from one man every nation of mankind to live on all the face of the earth, having determined allotted periods and the boundaries of their dwelling place*

How Did the Different Races of Men Arise From Noah and His Family?

- The Bible does not speak of races per se; it speaks instead of tribes, people groups, languages and nations.
 - Revelation 5:9b - ... *and by your blood you ransomed people for God from every tribe and language and people and nation*
 - Revelation 13:7 - *And authority was given it over every tribe and people and language and nation*
- Therefore, in one sense, there is really only one race: the human race!
- Clearly, though, there are groups of people who have certain features (e.g., skin color) in common, which distinguish them from other groups.

How Did the Different Races of Men Arise From Noah and His Family?

- **We have seen in our study of Genesis how the population that descended from Noah's family had one language and by living in one place were disobeying God's command to "fill the earth" (Genesis 9:1, 11:4).**
- **God confused their language, causing a break-up of the population into smaller groups which scattered over the earth (Genesis 11:8-9).**
- **Modern genetics show how, following such a break-up of a population, variations in skin color, for example, between the dispersed groups can develop in only a few generations.**

How Did the Different Races of Men Arise From Noah and His Family?

- We all have the same coloring pigment in our skin—melanin.
- Melanin is a dark-brownish pigment that is produced in different amounts in special cells in our skin.
- Those who have none (like albinos, who inherit a mutation-caused defect, and cannot produce melanin), have a very white or pink skin coloring.
- Those with relatively little melanin are European white.
- Those with significantly large amounts of melanin, are black.
- And in between, of course, are various shades of brown.

How Did the Different Races of Men Arise From Noah and His Family?

- **How is it that many different skin colors can arise in a short time?**
- **Remember, whenever we speak of different 'colors' we are referring to different shades of the one color, melanin.**
- **If a person from a very black people group marries someone from a very white group, their offspring, known as "mulattos", tend to be mid-brown.**
- **It has long been known that when mulattos marry each other, their offspring may be virtually any 'color,' ranging from very dark to very light.**
- **Understanding this gives us the clues we need to answer our question, but first we must look, in a simple way, at some of the basic principles of heredity.**

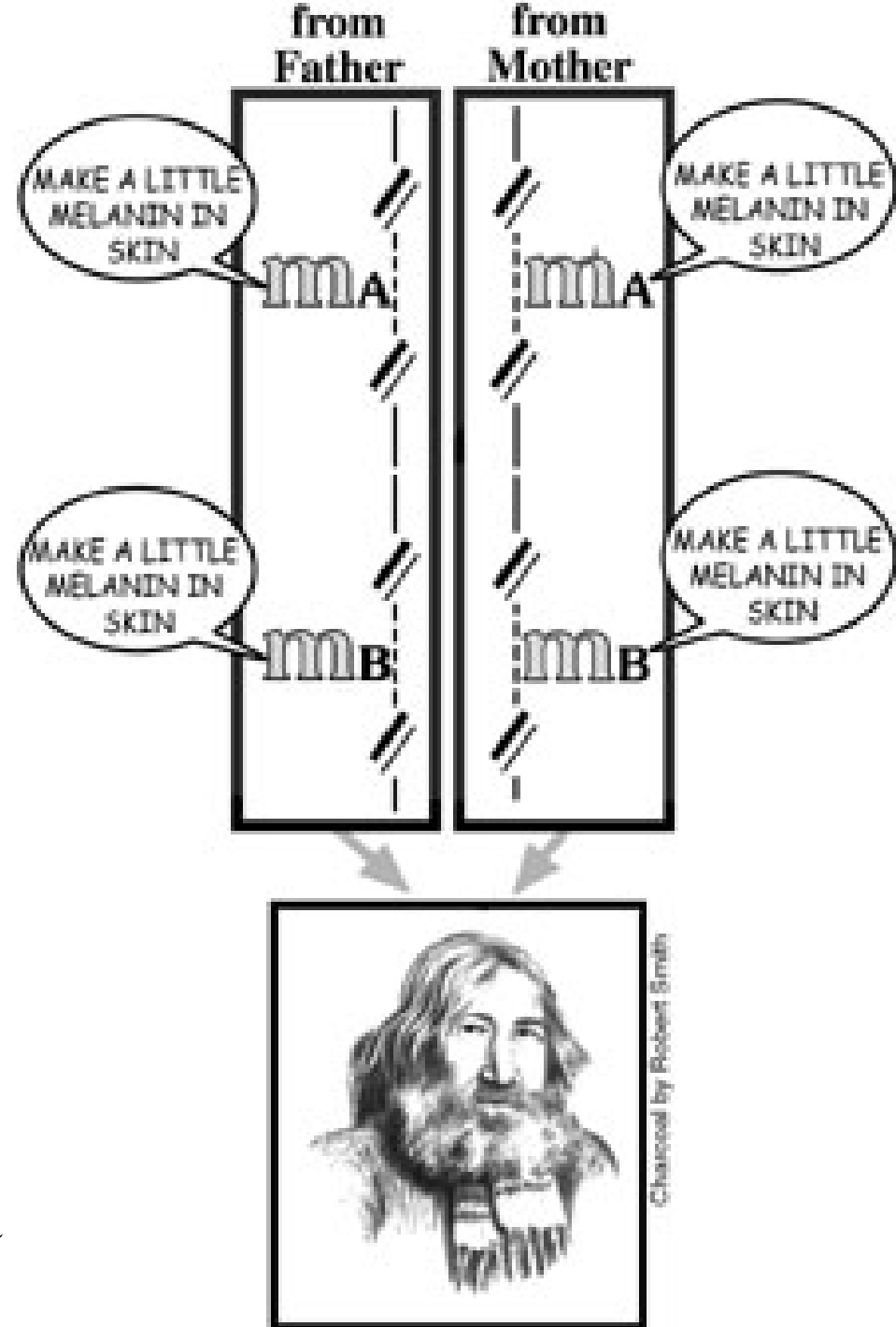
- We know that skin color is governed by more than one pair of genes.
- For simplicity, let's assume there are only two, located at positions A and B on the chromosomes.
 - One form of the gene, 'M', tells the body to make lots of melanin;
 - Another form of the gene, 'm,' says to only make a little melanin.
- The number of 'M' versus 'm' forms of the gene that exist at each position would determine the skin color of the individual.

A 'black' gene combination



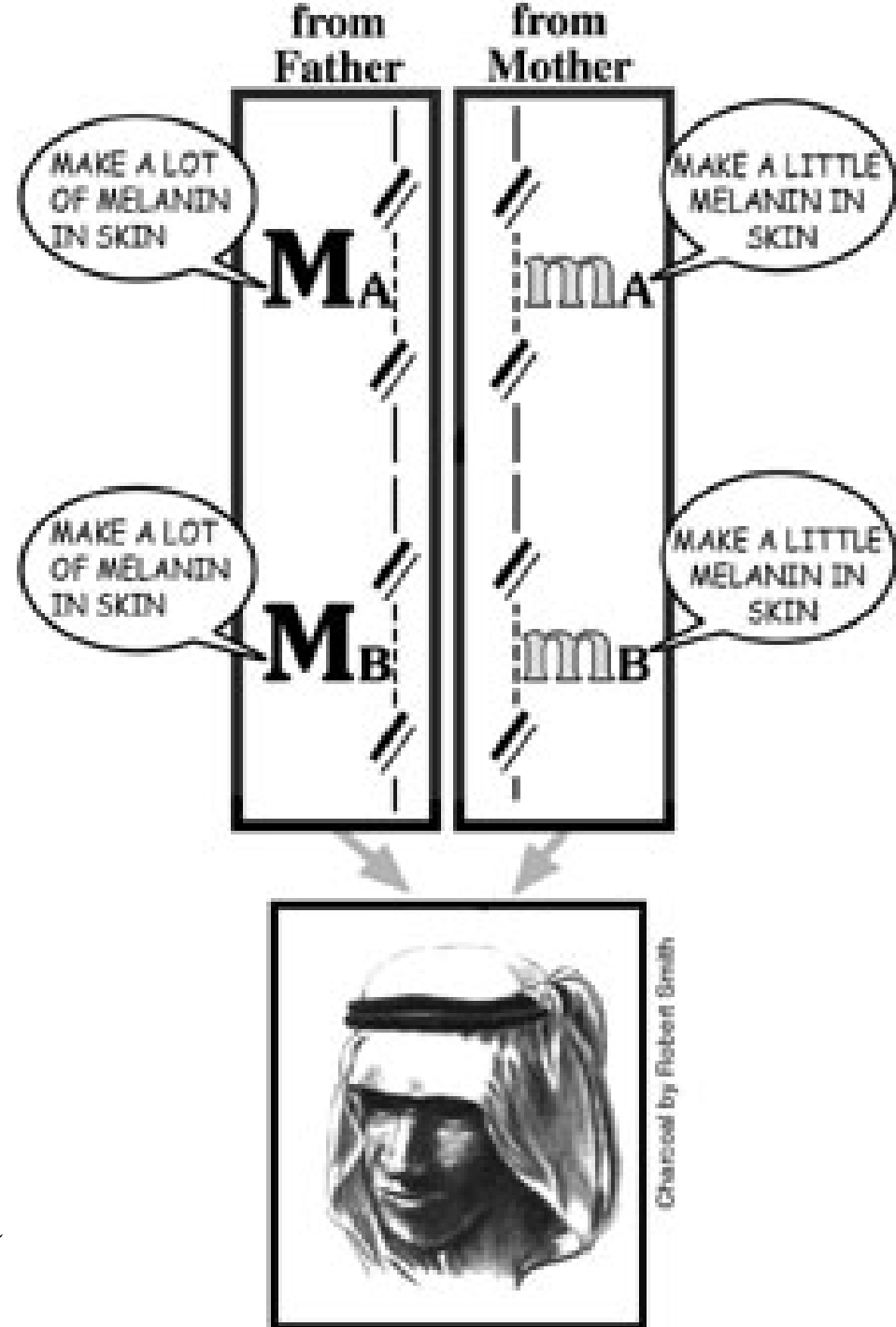

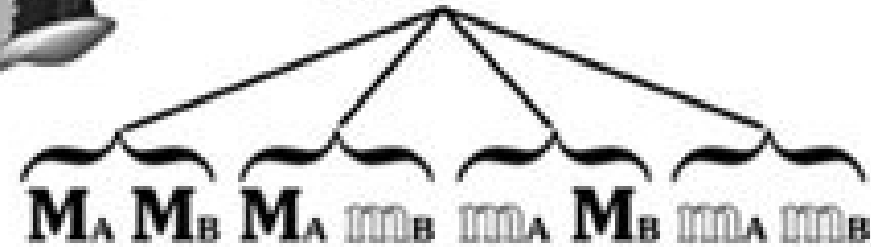

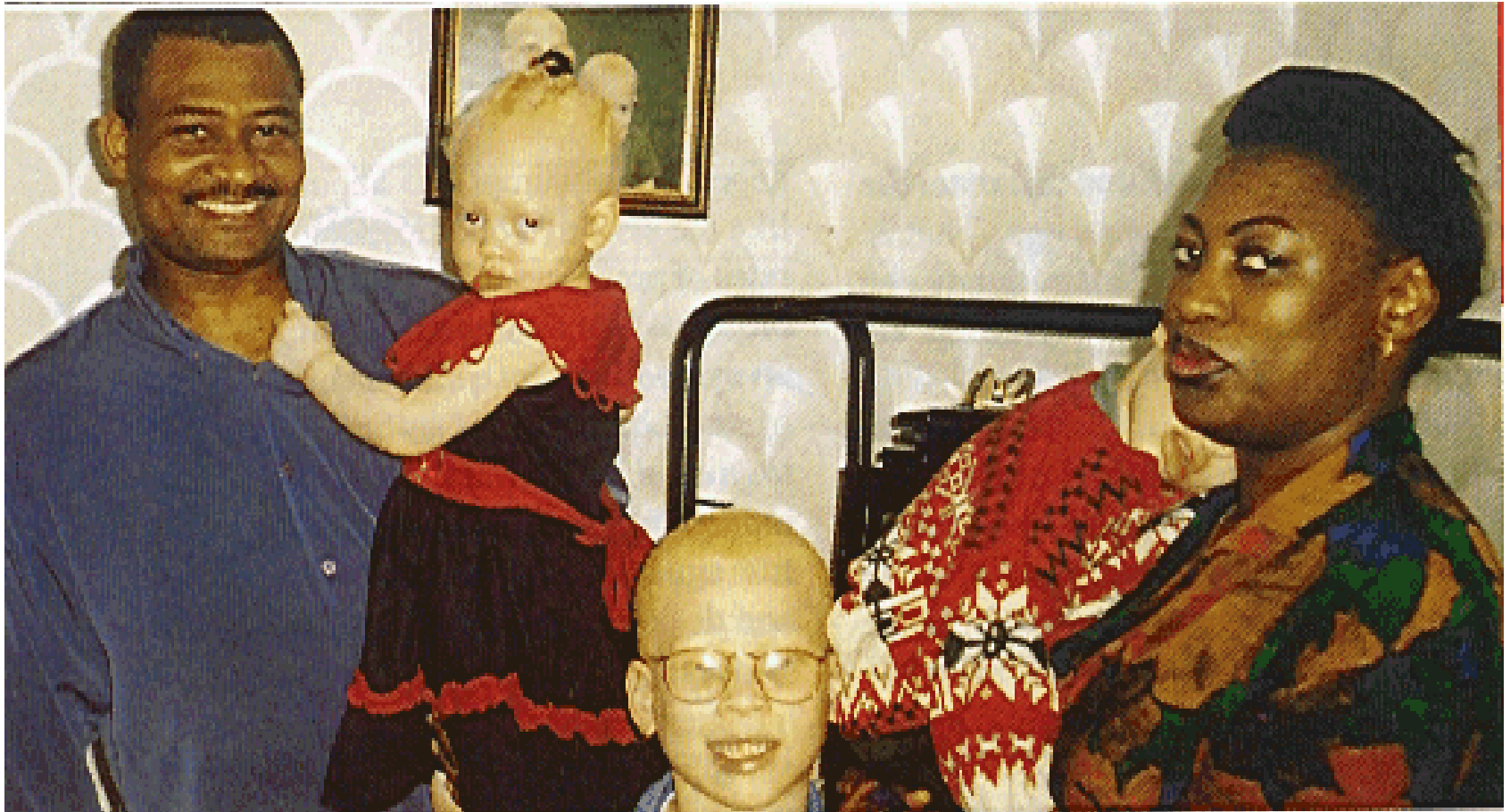

How Did the Different Races of Men Arise From Noah and His Family?

- Noah and his family were probably mid-brown, with genes for both dark and light skin.
- Likewise, as all the factors for skin color were present in Adam and Eve, they would most likely have been mid-brown.
- In fact, most of the world's population today is still mid-brown.

How Did the Different Races of Men Arise From Noah and His Family?

- **After the Flood, for the century or so until the tower of Babel incident, there was only one language and one culture group.**
- **Assuming there were no barriers to marriage within this group, this would tend to keep the skin color of the general population away from the extremes.**
- **To produce a change in skin color, you would need to break the larger population of humans into smaller groups and keep them separate, that is, prevent interbreeding between groups.**

How Did the Different Races of Men Arise From Noah and His Family?

- **This is exactly what happened at Babel. Once separate languages were imposed, there were instantaneous barriers. Entire groups which spoke the same language suddenly had difficulty relating to and trusting those who spoke a different language.**
- **Thus, they moved away from each other into different environments. This, of course, is what God intended.**

How Did the Different Races of Men Arise From Noah and His Family?

- It is unlikely that each small group would carry the same broad range of skin colors as the original, larger group.
- One group might have more dark genes, on average, while another might have more light genes.
- The same thing would occur with other characteristics as well: nose shape, eye shape, etc.
- And since they would intermarry only within their own language group, these differences would no longer be averaged out as much as before.

How Did the Different Races of Men Arise From Noah and His Family?

- So, by isolating groups of peoples with certain genetic characteristics, the dispersion of the human race at Babel, would have contributed to the development of people groups with distinct characteristics - some of which we consider to be “racial” characteristics.

How Did the Different Races of Men Arise From Noah and His Family?

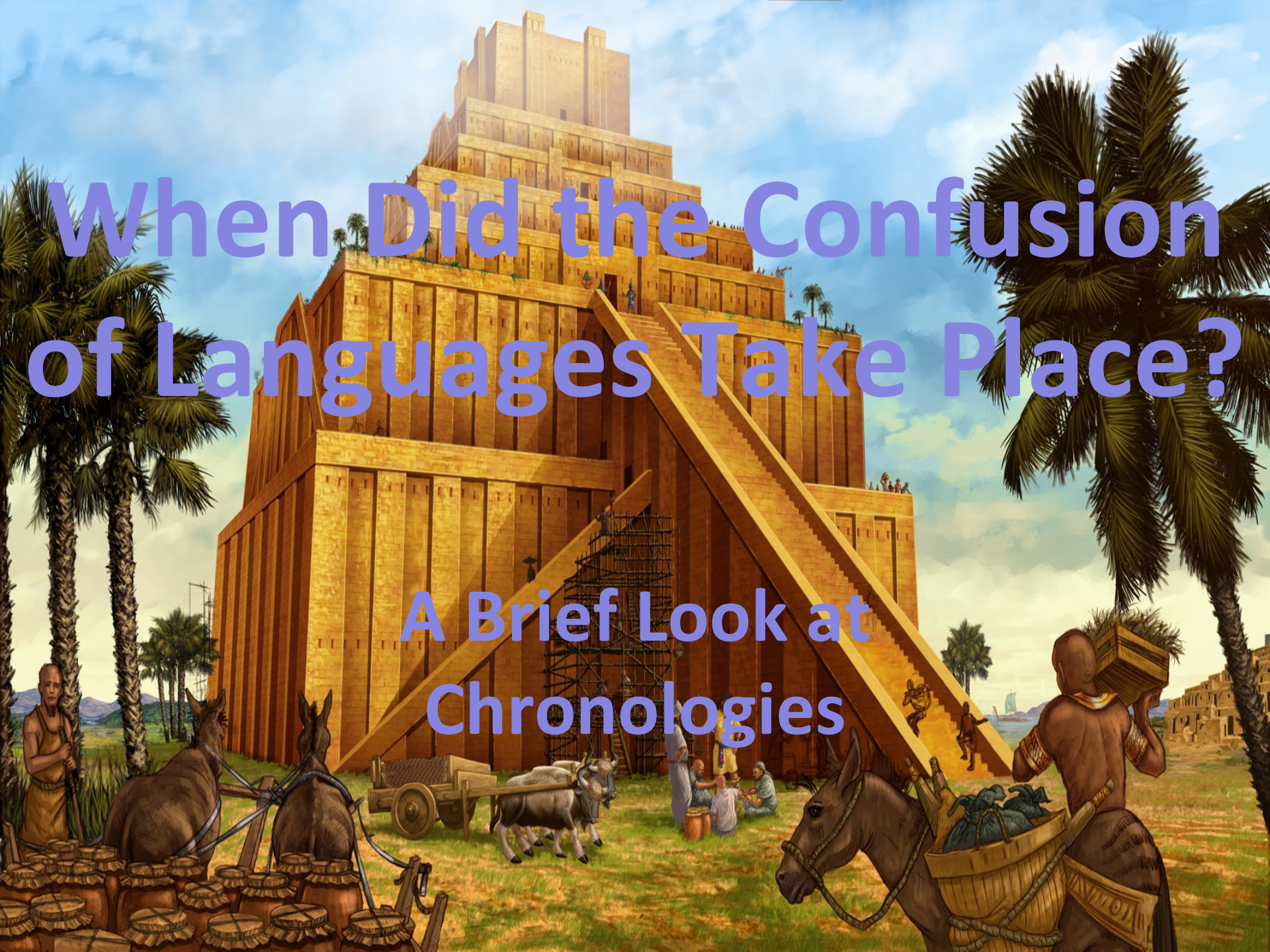
- One additional factor that probably led to the development of particular characteristics within the dispersed people groups after Babel is natural selection.
- For example, because of the protective factor of melanin, those with darker skin would have been more likely to survive in areas where sunlight is more intense (warmer, tropical areas near the equator), as they are less likely to suffer from diseases such as skin cancer.
- Those with lighter skin, on the other hand, lack the melanin needed to protect them from the harmful UV rays, and so may have been more likely to die before they were able to reproduce.

How Did the Different Races of Men Arise From Noah and His Family?

- On the flip side, melanin works as a natural sunblock, limiting the sunlight's ability to stimulate the liver to produce vitamin D, which helps the body absorb calcium and build strong bones.
- Since those with darker skin need more sunlight to produce vitamin D, they may not have been as able to survive as well in areas of less sunlight (northern, colder regions) as their lighter-skinned family members, who don't need as much sunlight to produce adequate amounts of vitamin D.

How Did the Different Races of Men Arise From Noah and His Family?

- Of course, these are generalities. Exceptions occur, such as in the case of the darker-skinned Inuit tribes living in cold northern regions.
- However, their diet consists of fish, the oil of which is a ready source of vitamin D, which could account for their survival in this area.

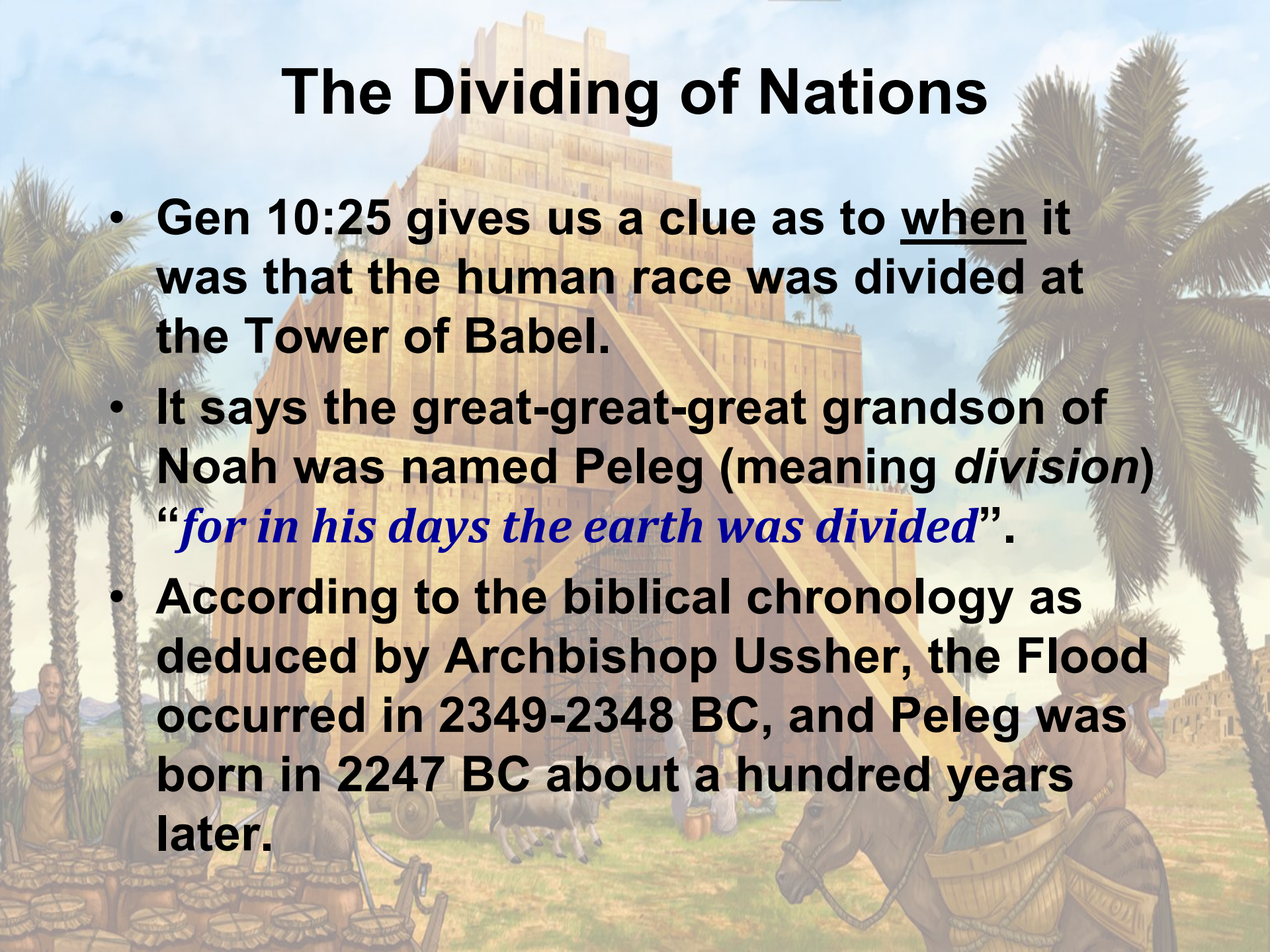

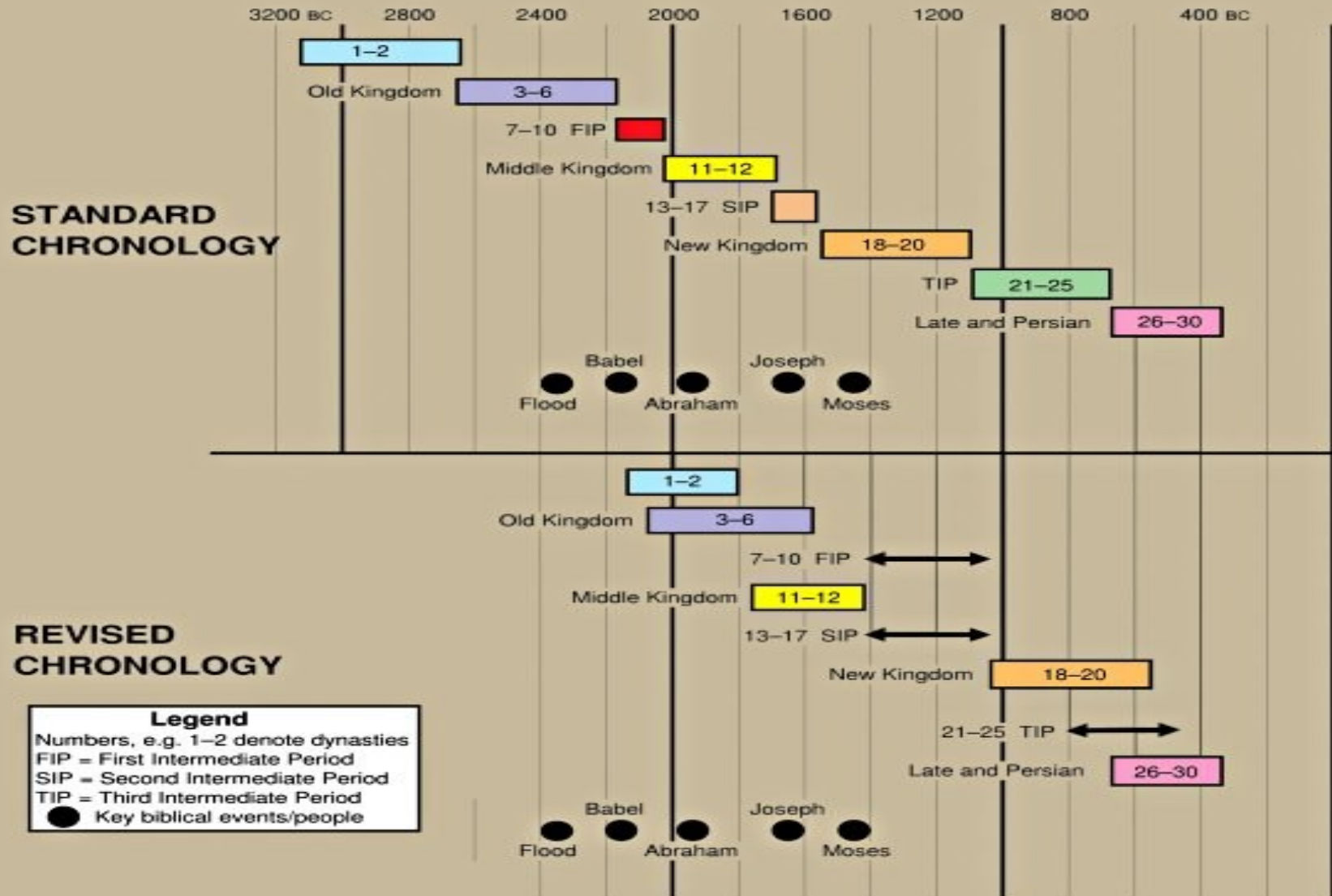

The Dividing of Nations

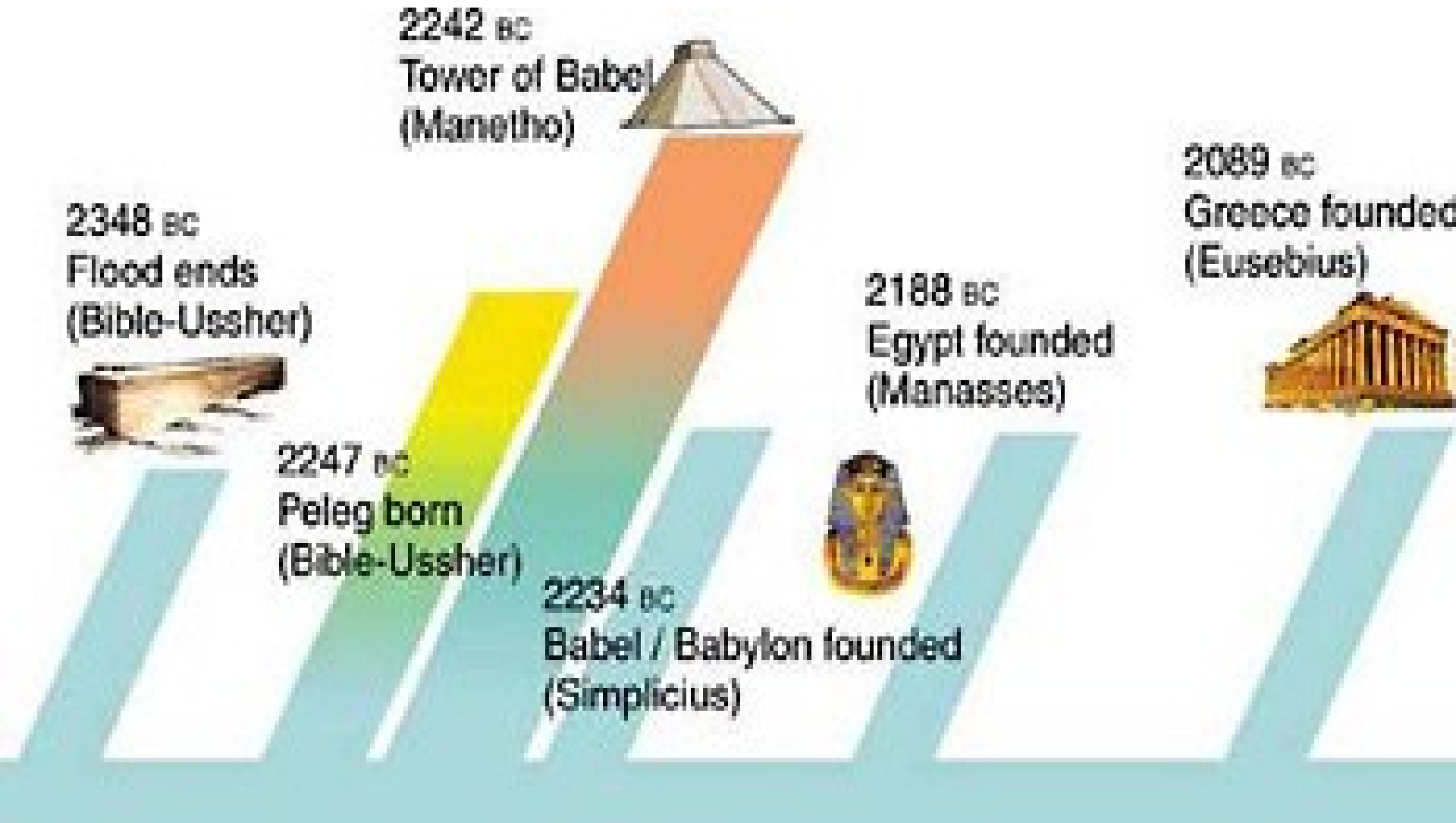
- Gen 10:25 gives us a clue as to when it was that the human race was divided at the Tower of Babel.
